GENERAL INFORMATION & SALES NOTES

LOCATION: The sale will be held at NWA J36 Auction Centre, Crooklands, Cumbria LA7 7FP (Sat Nat LA7 7NU)

CONDITIONS OF SALE: The sale will be held subject to the rules and regulations of each breed society, the conditions of sale as recommended by the Livestock Auctions Association and the Auctioneers Standard Conditions of sale.

METHOD OF SALE: A Society Levy will be deducted from the vendors account and paid to the relevant Society. Badger Face Texel 1%, Dutch Spotted 1%. All sheep will be sold in guineas (105 pence) and in catalogue order, unless any change is announced by the Auctioneer.

MAEDI VISNA: MV Accredited sale only.

REGISTRATIONS: All stock in the sale are registered with the appropriate breed societies, unless otherwise stated. All sheep must be double tagged. The vendor shall be responsible for correctness of identity. Any tags which are tampered with, handwritten/bear marks, are faulty or illegible will be rejected from the sale.

PEDIGREE TRANSERS: A transfer fee will be charged to the purchaser if they wish to transfer their purchase into their flock. Badger Face Texel £5 + VAT , Dutch Spotted £0.

BYE-LAWS: A copy of each societies bye-laws can be found in the Junction 36 livestock office.

NUMBERING: All Sheep will be identified with lot numbers hung around their neck (Dutch Spotted) or backstamped (Beltex & Badger Face Texel).

BIDDING FACILITIES AVAILABLE:

In Person – Please register for an account in the office prior to the sale commencing.

By Telephone – please contact the office prior to the sale to state you want to do a telephone bid and which lot(s) you would like to bid on.

Online – please register with nwa.auctionmarts.com prior to the sale. Once the sale is up and running you will then be able to bid. To register you will need full name, address, email and contact number.

SETTLEMENT AND CLEARANCE OF STOCK: Settlement in full is due immediately at the close of the sale. No animal may leave the sale premises without an official 'Pass Slip' obtainable from the Auctioneers upon settlement.

ERRORS AND OMISSIONS: The Auctioneers can accept no responsibility for any errors or omissions printed in this catalogue.

METHOD OF SALE: All sheep will be sold in guineas (105 pence) and in catalogue order, unless any change is announced by the Auctioneer.

1. All sheep will be sold under the Conditions of Sale of the Livestock Auctioneers Association.
2. A Society Levy of 1% will be deducted from the vendors account and paid to the Badger Face Texel Sheep Society.
3. Transfer Fee - A fee of £5 + VAT will be charged to the purchaser if they wish to transfer their purchase to their flock.
4. All sheep to be fully registered with the Badger Face Texel Society. All sheep must have official ear tattoos or tags and also be tagged in accordance with the relevant DEFRA regulations. The Vendor shall be responsible for the correctness of identity.
5. Pre Sale Inspection - All sheep forward for sale will be subject to a Society inspection. Any animal which does not reach the inspection standard will not be eligible for sale. The inspection decision will be final and any animal failing, must be removed immediately from the sale and forfeit the entry fee. No appeal is permitted.
6. Substitutes – Details of Substitutes must be submitted to the Auctioneer/ Society Secretary 48 hours prior to sale.
7. The Badger Face Texel Sheep Society Sub-Register allows females registered with the Beltex, Blue Texel & Texel (inc Dutch Texels) Society's to be used for Badger Face Breeding. All females entered into the Badger Face Sub-Register can only be bred with a Badger Face Ram. These animals entered in the Sub- Register are not guaranteed to breed Badger Face Texel Sheep. If resulting offspring are correctly marked with Badger Face Markings they can enter the main registry or female offspring retained in the sub registry to be used for future breeding.
8. The upset (minimum) price is 300gns .

BELTEX SHEEP SOCIETY
CONDITIONS OF SALE AND GENERAL INFORMATION



1. All UK-bred sheep entered at Society/Club sales must be fully registered and all fees paid prior to the sale, with the exception of spring ewe and lamb sales where lambs need only be birth notified prior to sale and fully registered, at cost to the vendor, if sold.
2. All tags must comply with UK legislation and Society rules on identification.
3. Substitutes must be declared to the Society within the specified time stated on the sale entry form and catalogue and must be marked with a red dot on the loin.
4. Scrapie genotyping is voluntary but is included in the standard DNA sample for sires used and ewes flushed. All sheep catalogued with scrapie genotype must have valid certificates.
5. The upset (minimum) price is 400gns at the Premier Sale. At all other Society/Club sales, the upset price shall be decided between the Society/Club and the auctioneer.
6. Runs are limited to 10, extra runs are placed at the end of the sale.
7. All sheep entered for Society/Club sales must be inspected by a panel of inspectors appointed by the Society. Some sales will also have a Veterinary Officer aiding with the inspection.
8. The inclusion of any animal in the show and/or sale following any inspection is no warranty that the particular animal meets any criteria or criterion in respects of any standards or will do so in the future.
9. Entry forms must be submitted with all relevant paperwork.
10. Any sheep which has not passed Society/Club inspection should be removed from the vendor's pen as soon as possible, and must not be offered for sale, or advertised or promoted, in the ring.
11. No animal to be sold outside of the ring before entering the sale ring.
12. All animals must be sold in catalogue order.
13. Any sheep to be sold at Society sales must be registered in the flock from which it is to be sold by 31 May in the year of sale.
14. All sheep forward must be back-stamped with the lot number, with the exception of those at spring ewe and lamb sales. Failure to do so will result in rejection from sale.
15. Any rams with semen taken or retained before sale, or females which have been flushed and embryos recovered before sale, must be declared on the entry forms and catalogue and announced at the time of sale. Failure to do so will result in the purchaser having the right to return the sheep. Costs may be incurred by the vendor.
16. Recipients carrying pedigree embryos will be allowed to be sold at the in-lamb female sales after fully registered sheep.
17. All sheep entered at in-lamb sales will be scanned at time of inspection. If any ewe or gimmer is found not to be in lamb these will be rejected from the sale. If any empty ewe lamb is found to be in lamb these will be rejected from the sale.
18. Substitutes allowance per vendor at any sale is three shearling rams, and two per other section. These must be notified to the Society by the time specified on the entry form/catalogue. No substitutes will be allowed on the day. Any un-notified substitutes must be removed from the vendor's pen as soon as possible and must not be offered for sale through the ring.

Note re Point 15: Council advise the following: Tick the box on the entry forms and make sure information is given out at time of sale. The vendor must discuss fully with the purchaser any details of retained semen/embryos, specifically whether for own use or if intending to sell. This should be agreed between vendor and purchaser, preferably in writing and signed by both parties.

Inspections

1. Tags which do not comply with UK legislation and Society requirements will result in the sheep being rejected at inspection. From 2008, all registered lambs must carry tags with the Society logo. Check that tags are correct at time of entry so that replacement tags can be ordered before the sale.
2. All sheep forward must be back-stamped with the lot number, with the exception of those at spring ewe and lamb sales. Failure to do so will result in rejection from sale.
3. Sheep which have failed inspection must be removed immediately from the market premises. Vendors are advised to check their animals thoroughly prior to departure from home.
4. Any animal rejected for testicle abnormality (including size) or incorrect mouth is not allowed to be entered or substituted at later Society/Club sales, with the exception of lambs which may be entered at sales the following year as shearlings.
5. Inspection will include the following points – tags, teeth, testicles, udder, muscularity and any other points deemed necessary by Council as they see fit.

Inspection Standards

- A. Teeth to be inspected and assessed at the discretion of the inspector/veterinary officer. Teeth must meet the pad, not be overshot or undershot, and no tampering with teeth is permitted.
- B. All sheep should be mobile and rams capable of natural service.
- C. Testicles should be of even size, free of abnormalities and move freely. Minimum testicle size – 27cm for ram lambs and 30 cm for shearling rams and aged rams. Testicles will be measured at the vet/inspector's discretion.
- D. Udders should be correct and free of any hardness or abnormalities.

The vet and inspector's decision will be final at each sale.

Shows at Sales

- A. Each vendor is allowed two entries in each pre-sale show class, bar the Carlisle Premier Sale where only one entry per class is allowed.
- B. All exhibitors should be dressed in a white coat in the show ring.
- C. Exhibitors are permitted to prepare their sheep to the best of their ability.
- D. It is the responsibility of the exhibitor to ensure that each exhibit is available for judging at the correct time.
- E. All prize winners must be offered for sale at auction by the exhibitor at the sale following the show, otherwise awards may be withheld, and prize monies forfeited.
- F. The decision of the judge is final.

Sales held under the auspices of the Beltex Sheep Society

All sheep sold at any Society/Club sale must be registered with the Beltex Sheep Society. Cross-bred sheep must not be listed in any Society catalogue unless carrying pedigree embryos.

Dispersal Sale (No Inspection required) Production and Reduction Sales (Inspection required). Each vendor to be balloted after the collective sale. Sales to be held at the end of the collective sale and no sheep to be shown in the pre-sale show.

Sale Conditions

The sale terms and conditions of the LAAS / IAAS shall apply to Beltex Society and club sales with the exception of the duration of the stock ram warranty.

Rams purchased at Society and club sales must prove to be capable of, and effective at, getting at least 1 female in lamb by 15th December in the year of purchase.

Claims must be notified to the auctioneers by 31st December and must be supported by vets' reports and any other proof of infertility or incapability. No claim after that date will be accepted.

The auctioneers shall be mediators in disputes between buyer and seller.



DUTCH SPOTTED SHEEP SOCIETY
CONDITIONS OF SALE AND GENERAL INFORMATION
Issued February 2025



1. **ENTRIES** – All animals entered must be fully registered and, on the Grassroots Database, with all fees paid at least 7 working days before the date of sale entry. Failing to do this will result in the animal being ineligible to be sold.
All sheep must be tagged in accordance with the rules of Dutch Spotted Sheep Society and with the relevant DEFRA regulations. The vendor shall be responsible for the correctness of identity.
2. **METHOD OF SALE** – All sheep will be sold in guineas (105 pence) and in catalogue order unless alteration is announced by the auctioneer. A market commission at the mart's rate will be charged on all sheep sold, plus a further 1% sales levy, which will be paid to the DSSS.
Graded animals will always be sold after all the purebred animals in MV and non MV sections.
3. **CONDITIONS OF SALE** – The sale is held subject to the Livestock Auctioneers Association Conditions of Sale and the Rules of the DSSS.
4. **UPSET PRICE** – The minimum upset price is set at 300gns (200gns for Graded females). Sheep unsold but passing inspection will be allowed into subsequent Society Sales but not on the same day.
5. **MAEDI VISNA** - All sheep from MV Accredited flocks will only be accepted into the market and penned for sale if they are accompanied by a current and correctly completed Maedi Visna Accreditation Scheme Certificate.
6. **NUMBERING** – All entries must be identified by their catalogue number by means of a neck tie or by numbers printed clearly on the animals back in paint and will be sold in catalogue order.
7. **SUBSTITUTE ENTRIES** – All substitute entries **MUST BE NOTIFIED** to the Registrations Secretary not less than 7 days before the sale. Substitute entries must be marked with a **RED DOT ON THE SHOULDER**. Substitutes are limited to 1 per vendor per section. Animals can only be substituted by another animal of same age and class. Animals not notified to the Registrations Secretary in the allotted time will be refused entry into the sale.

INSPECTIONS - All sheep will be subject to an official society veterinary inspection before the sale. Society representatives appointed by the society will assist with inspection administration. The inspector is empowered to disbar any animal which in his/her opinion does not meet the necessary standard. The decision of the inspector(s) will be final. Any animal failing inspection on structural or conformational criteria will not be allowed to be sold on the day of the sale, nor any other Society sale in the same year. Neither the Inspectors, the Society nor the Auctioneers will be liable to the owners of such animals or any other person or company for damage or any loss arising from rejection.

Sheep rejected from the sale must be marked with a **YELLOW DOT ON THE LOIN** and should be moved well away from the sale's penning area and not further exhibited for sale; no advertising, promotion or sale of such a sheep is allowed on market premises.

Any sheep withdrawn from a sale, passing inspection and gone through the ring, but unsold will be allowed to enter subsequent Society sales but will have to be presented for inspection again.

Inspection Criteria

Lot Number: The lot number must correspond with the number entered in the catalogue. Animals without the correct identification will be rejected from the sale.

Disease: the animal is not suffering from any infectious disease.

Mobility: sheep should be mobile and sound with no feet and/or leg structural issues.

Teeth to be assessed whereby if any incisor teeth that are felt beyond the pad, as demonstrated by catching on fingers when running from the pad downwards, or when they are so far beyond the pad that they do not catch the finger, will be rejected.

When males are being sold, testicles should be of even size, move freely and free from abnormalities. Ram lamb's minimal scrotal circumference is 28cm and Shearling Rams minimal scrotal circumference is 33cm.

When females are being sold, the udder should be correct and free from abnormalities.

Note: Animals which do not meet animal *welfare standards* such as lame animals will be rejected from that sale, however are eligible to be entered for future sales in that year, provided they are inspected and pass inspection at that future sale.

Important Note: *Although the animals have undergone a veterinary inspection according to the DSSS inspection criteria, it remains the responsibility of the party or parties purchasing stock at society sales to ensure they are satisfied with the quality and standard of the animals before engaging with any purchase.*

SHOWS AT SALES: A show will not be held at a society if there are fewer than 30 purebred animals entered.

Animals bred by the judge cannot be presented for judging.

10 **SETTLEMENT AND CLEARING OF STOCK** – Settlement in full is due immediately at the close of sale. No animal must leave the sale premises without an official "pass slip" obtainable only from the Auctioneers upon settlement.

11 **EXPORT TO NORTHERN IRELAND** – As of the 1st January 2021, the rules for exporting sheep from Great Britain to Northern Ireland and the European Union have changed. – No direct export or vendor returns will be available under current animal health rules. It will be the responsibility of the purchaser and/or vendor to make necessary arrangements for the sheep going to Northern Ireland. **DISCLAIMER-** the responsibility for export of sheep rests with either the purchaser or the vendor and not the Dutch Spotted Sheep Society or Auction Company accommodating the sale.

12 **FLUSHED SHEEP** – where females have been flushed, with or without, embryos being recovered before the sale must be declared in the catalogue and announced at the time of the sale. Failure to do so will result in the purchaser having the right to return the sheep – costs may occur.

13 **SEMEN** – rams being sold where semen is being retained, details must be disclosed at the time of sale.

14 **FLOCK DISPERSAL** – In prior agreement with the society, a full flock dispersal can take place on the same day as a Society sale, but not as part of the main sale and must be catalogued in a separate publication; There can be one dispersal sale only per flock and no further sheep can be registered for the flock once a dispersal sale has taken place. Dispersal sheep will not be inspected, and will not be eligible for showing. If advertised alongside the society sale, then the levy fee applicable to the main sale will apply.

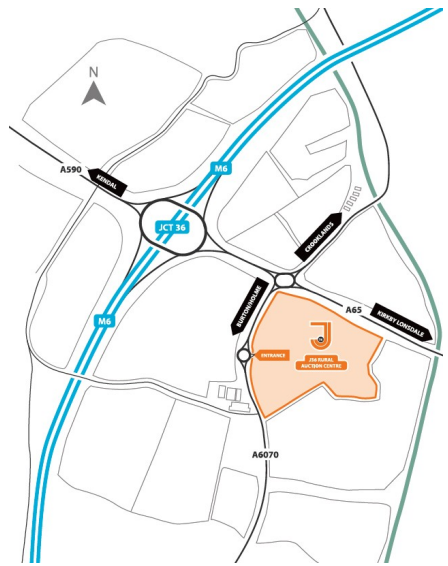

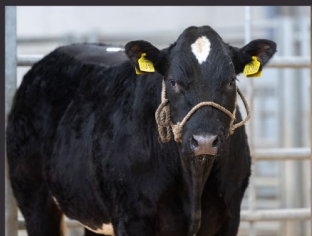
