- 1 All imported sheep to be registered with DSSS must be listed on this document.
- 2 The breeder's name and address must be shown.
- 3 The breeder must have given consent to our GDPR by signing the relevant form (applications cannot be completed without this)
- 4 From 15 December 2022, an imported sheep of any age can be registered at a fee of £300 (including VAT), but please note that if the sheep is not registered within 2 months of importation date the fee doubles.
- 5 The importer is the person whose name appears on the import licence.
- 6 The naming of rams is compulsory and for imported females it is optional. The name of the sheep can begin with any letter and will NOT contain any prefix. The name of the sheep cannot exceed 21 letters.
- 7 Full EID Ear Tag numbers must be provided for all sheep plus Sire and Dam details as a minimum requirement,
- 8 Where more breeding details over and above the Sire and Dam are known, please continue on a separate sheet of paper.
- 9 DSSS import inspection photos or videos must accompany this registration for all imported sheep as per the inspection rules.
- 10 A copy of the original import certificate must also be submitted.
