## Website Terms of Use

### Terms of website use

1. This page (together with the documents referred to on it) tells you the terms of use on which you may make use of our website [www.dutchspottedsheep.co.uk](http://www.dutchspottedsheep.co.uk), whether as a guest or a registered user. Please read these terms of use carefully before you start to use the site. By using our site, you indicate that you accept these terms of use and that you agree to abide by them. If you do not agree to these terms of use, please refrain from using our site.

### Information about us

2. [www.dutchspottedsheep.co.uk](http://www.dutchspottedsheep.co.uk) is a site operated by the Dutch Spotted Sheep Society a charity registered in England with charity number 1171992 and whose registered office is at Harrison & Heatherington, Borderway Mart, Rosehill, Carlisle, Cumbria, CA1 2RS. (“**We**”).
3. We are a charity.

### Accessing our site

4. Access to our site is permitted on a temporary basis, and we reserve the right to withdraw or amend the service we provide on our site without notice (see below). We will not be liable if for any reason our site is unavailable at any time or for any period.
5. From time to time, we may restrict access to some parts of our site, or our entire site, to users who have registered with us.
6. If you choose, or you are provided with, a user identification code, password or any other piece of information as part of our security procedures, you must treat such information as confidential, and you must not disclose it to any third party. We have the right to disable any user identification code or password, whether chosen by you or allocated by us, at any time, if in our opinion you have failed to comply with any of the provisions of these terms of use.
7. When using our site, you must comply with the provisions of acceptable use.
8. You are responsible for making all arrangements necessary for you to have access to our site. You are also responsible for ensuring that all persons who access our site through your internet connection are aware of these terms, and that they comply with them.

19. All conditions, warranties and other terms which might otherwise be implied by statute, common law or the law of equity.
20. Any liability for any direct, indirect or consequential loss or damage incurred by any user in connection with our site or in connection with the use,

inability to use, or results of the use of our site, any websites linked to it and any materials posted on it, including:

- a. loss of income or revenue;

21. wasted management or office time; and
22. whether caused by tort (including negligence), breach of contract or otherwise, even if foreseeable.
23. This does not affect our liability for death or personal injury arising from our negligence, nor our liability for fraudulent misrepresentation or misrepresentation as to a fundamental matter, nor any other liability which cannot be excluded or limited under applicable law.

#### **Information about you and your visits to our site**

24. We process information about you in accordance with our privacy policy. By using our site, you consent to such processing and you warrant that all data provided by you is accurate.

#### **Transactions concluded through our site**

25. Contracts for the supply of goods, services or information formed through our site or as a result of visits made by you are governed by our terms and conditions of supply.

#### **Uploading material to our site**

26.
